**IMPORTANT NOTICE IN CONNECTION WITH HOLDING OF GENERAL BODY MEETING AND CONDUCTING ELECTION OF STATE BANK OF INDIA OBCs EMPLOYEES WELFARE ASSOCIATION – CHANDIGARH CIRCLE**

The tenure of the existing executive body of State Bank of India OBCs Employees Welfare Association – Chandigarh Circle is going to expire in the month of June 2026. As per the resolution passed by the Executive Committee in its meeting, held on 13.12.2025, the term of the existing Executive Committee has been extended by a further three months. Accordingly, the election of the Association will be conducted by 30.08.2026.

A meeting of the Executive Committee Members of the Association was held on 16.03.2016 (Monday) at Gymkhana Club, Panchkula, all the central executive committee members were presented in the meeting.

1. The following agenda was resolved in the Meeting unanimously:

- a) The election for new executive body to be conducted well before the expiry of the extended period i.e. 30.08.2026.
- b) Three (3) members election committee has been formed comprising One (1) President, One (1) Secretary & One (1) Member. Mr. Mukesh Kumar Saini has been appointed as the President of the election committee and also let him authorize to select other two (2) members of the committee and take all the decision for conducting free and fair election unanimously.
- c) Sh. Inderjeet Singh Sidhu (Retd. Chief Manager) Mobile No. 9779586378 has been appointed as Presiding/Returning Officer for the election.
- d) Mr. Mukesh Kumar Saini (President of election committee) has appointed Mr. Gourav Verma (RBO-3) Panchkula as Election committee secretary and Mr. Ramesh Kumar Patel (Airawat Branch) as Member of the committee.
- e) Sh. Sh. Inderjeet Singh Sidhu (Retd. Chief Manager) has given his consent as well as acceptance for appointing him as Presiding/Returning officer for the election of State Bank of India OBCs Employees Welfare Association- Chd. Circle

2. The Presiding/Returning officer has authorized Mr. Mukesh Kumar Saini (President of election committee) to declare the schedule of election and upload nomination form, List of the voter at [www.sbiobcchd.org](http://www.sbiobcchd.org) and receive the nomination forms from all the aspiring contestants on his behalf only for onwards submission to returning Officer for their scrutiny and taking final decision.

3. After the discussing with the Returning Officer and Election committee. The election schedule is placed below.

- a) **Date of filing of the Nomination** - From 01June 2026 to 06June 2026
- b) **Date of Withdrawn of Nomination** - From 09 June 2026 to 10 June 2026
- c) **Date of Scrutiny of nomination** - 12 June 2026
- d) **Date of release of final list** - 15 June 2026
- e) **Date of Election** - 11 July 2026

#### **4. NOMINATIONS:**

- a) The completely filled nominations/withdrawals (in original) as per specimen enclosed "Annexure-A" shall be sent/delivered by post/hand/courier in a sealed cover addressed to The Returning Officer C/o SBI OBC Employees Welfare Association – Chandigarh Circle, State Bank of India, Local Head Office Chandigarh, Sector-17-A, Chandigarh-160017. **Electronic/scan copy of nomination forms sent through email etc. will not be accepted.**
- b) The membership roll for May 2026 will be reckoned for the validity of membership for the purpose of nomination forms.
- c) The nomination for any post shall be proposed by one member and seconded by another member posted anywhere in Chandigarh Circle.
- d) The member shall propose/second only one contestant.
- e) Candidate is allowed to contest for one post only and shall withdraw nominations from other posts, if any filed, on or before the last date for receipt of withdrawals, failing which his/her candidature will be cancelled for all posts.

#### **6. ELECTION PROCESS**

- I. On behalf of Returning officer, General Secretary will get the nomination form and the circular relating to the Election uploaded on our website i.e. [www.sbiobcchd.org](http://www.sbiobcchd.org). The contesting candidate will have to submit his/her nomination form by post in a seal cover addressed to the Returning Officer, C/o C/o SBI OBC Employees Welfare Association – Chandigarh Circle, State Bank of India, Local Head Office Chandigarh, Sector-17-A, Chandigarh after the duly filled and signed nomination form (scan copy) along with the signature of another member as proposer & seconder. (Original copy is to be sent by post/by hand/by courier). Electronic/scan copy of nomination forms sent through email etc. will not be accepted.
- II. The nomination is to be submitted to the returning officer by 06.06.2026 upto 5:00 PM.
- III. Only an employee of OBC category (who is member of the Association) posted in any of the branches/office of State Bank of India, Chandigarh Circle will be eligible for contesting the election.

- IV. After scrutiny of the nomination forms, the returning officer will upload the list of contesting candidates on our website and also upload specimen of the ballot paper on our website through the General Secretary.
- V. Only the OBC employees who are being shown in the electoral list are eligible for contesting the election and for casting his/her vote in the election.
- VI. The election shall be conducted by Hand Raising for all the posts at the venue of General Body Meeting at Tagore Theatre, Sector-18, Chandigarh on 11<sup>th</sup> July 2026.
- VII. After due scrutiny and counting of the votes in presence of the Returning officer and one independent observer who is not related in any way with the affair of election, the Returning Officer will declare the name of Post wise elected candidates. The result will be declared in the General Body Meeting and placed on our website ie. [www.sbiobcchd.org](http://www.sbiobcchd.org).
- VIII. In case of any dispute occurs, decision of the returning officer will be final and binding on all the concerns.
- IX. All Branches and other establishments like BPR cells, SAMB, SARB, Special branches, SBILD, RACCs, Mini RACPCs, DAC, CCPC, LCPC, Compliance & Risk Department, Circle Procurement Department, GOC, Mid Corporate Offices, LHO, AOs and RBOs will form the part of respective Region and AO (Module) in which they are geographically established.
- X. The Central Office Bearer(s) shall be elected by the members.
- XI. The Module/Regional Office bearer(s) shall be elected by the voters (members) posted in relevant Module/Region only.
- XII. The OBC employees, who have not submitted their membership form and want to contest the election, may submit their membership form on or before 10.05.2026.

The returning officer will only take the task in their hands once the hard copy of nominations is handed over to him.
